2022 Budget, (Liars Budget) reviewed

- COVID-19 Budget Impacts
  - Major revenue accounts are up a total of \$219,731 YTD thru May from the same period in 2020.
  - Major revenue accounts are down a total of (\$251,337) YTD thru May from the same period in 2019.
  - American Rescue Plan Funds (ARP) was previously reported to be in the total amount of \$863,084. This amount was based on congressional estimates. The new estimated amount per the National League of Cities (NLC) is \$461,114. The first installment (50%) is anticipated to be received by 6/27/2021 and the following installment by 6/27/2022. Expenditures must be made by 12/31/2024. We are still awaiting final guidance from the U.S. Treasury and the Ohio Office of Budget and Management (OBM). This amount is based on initial Congressional estimates. We are still waiting for the US Treasury's final determination.

Income Tax / Net Profit Tax:

- 2019 Net Profits = \$900,774.88
- 2020 Net Profits = \$512,878.76
- 2021 Net Profits = \$409,929.16 YTD thru 6/26/2021
- 2021 revenue was budgeted at \$4,544.665.21
- 2021 revenue projection is on target to be \$4,799,002.20
